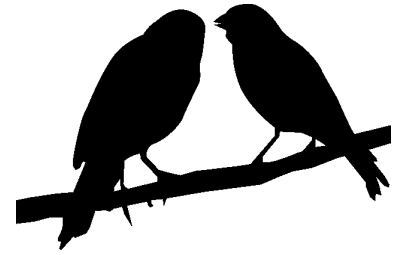

Bylaws change:

The SCVBA officers are recommending the following change to our SCVBA bylaws:

Combine the officer positions of Treasurer and Secretary. Add the officer position of Website and Social Media officer.

Background: With SCVBA communication being primarily by email, the officers feel that it is most efficient to have a single person be responsible for sending emails and collecting RSVPs and money. The officers feel that combining the position will create a more effective and streamlined communication system.

With regard to the creation of the Website and Social Media officer, the officers feel that maintaining our website, www.scvba.org, as well as developing other social media platforms, such as a Facebook page, would be best accomplished by having a specific officer designated for this position.
