

## E-FILING

After the resounding success of the representation by representatives from CCAP on the new e-filing system a repeat of that representation was held on Tuesday, May 13<sup>th</sup> 2014 in the Kinni River Theater Room at the UWRF University Center. This time the event was attended by more support staff than the first presentation but was equally useful and interesting. Saint Croix has each begun e-filing in several case types and this session was very informative on how to familiarize oneself with and navigate the e-filing system.

## STATE BAR OF WISCONSIN FEE ARBITRATION PROGRAM

When a dispute over legal fees arises between an attorney and his or her client, the attorney may feel the only choice seems to be going to court to sue the client. However, there is another option.

The State Bar of Wisconsin Fee Arbitration Program, supported with your dues dollars, provides a valuable service to members and their clients. The program was established so lawyers and clients who have a dispute about legal fees may submit their dispute to binding arbitration through the State Bar.

The program offers a private hearing between the lawyer and his or her client before a panel of arbitrators in an informal setting. Trained volunteers, lawyers and nonlawyers, hear the arguments of both sides before making a decision. The decision made by the arbitrators is final and binding, subject only to the appeal rights under Chapter 788, State Statutes.

In general, all fee disputes between clients and their lawyers may be arbitrated, but there are a few exceptions, such as: there was no lawyer/client relationship; the fees were set by law or statute; or the full amount of the fee was fixed or approved by order of a court, such as guardian ad litem fees.
